REQUIRED BID BOND: Each Bid must be submitted with a Bid Bond, Cashier's or Certified Check, or Cash as described in the Instructions for Bidders, in the amount of 10% of the total bid amount.

CONTRACTOR LICENSE: The class or classes of California contractor licenses required to propose on and perform the Work are: **A** – **General Engineering** and/or **C53** – **Swimming Pool** License(s).

PRE-BID CONFERENCE and SITE WALK: The District will conduct a mandatory pre-bid conference and site visit at **9:00 a.m. on July 24, 2019.** The conference will commence at **Oxnard High School, 3400 West Gonzales Road, Oxnard CA 93030 at pool location.** Attendance at the pre-bid conference and site visit is mandatory, and any Bidder that does not attend shall be deemed non-responsive.

BONDS: As described in the General Provisions, upon award, the successful Bidder must provide a Performance Bond and a Payment Bond, each in an amount equal to 100% of the total Contract Price, and each issued by a California-admitted surety as defined in Code of Civil Procedure Section 995.120.

LABOR LAW: The Project is a "public work" project that is subject to, among other laws, to Labor Code Sections 1720 through 1861, inclusive. As described in the Instructions For Bidders, each contractor (including subcontractors) must be registered with the California Department of Industrial Relations ("DIR") in accordance with Labor Code Section 1725.5, and Bidders must provide evidence of registration for themselves and their subcontractors. Each worker on the Project must be paid not less than the applicable prevailing rates of per-diem wages in the locality in which the Work is to be performed for each craft or type of worker needed to execute the Contract ("Prevailing Wages").
