It may also be considered fraud and the Contractor may be subject to criminal prosecution.



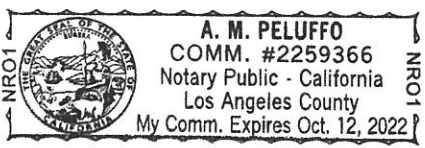
